NOTIFICATION

In exercise of the powers conferred by sub-section (4) of section 4 of the Karnataka Land Revenue Act, 1964 (Karnataka Act 12 of 1964) and after considering the administrative convenience of the Sub Divisions, the Government of Karnataka hereby proposed to modify the boundaries of the Sub Divisions of Ballari and Vijayanagara districts by altering following two Sub Divisions in the districts of Ballari and Vijayanagara.
