PREAMBLE:

The Hon'ble Chief Minister and Finance Minister in his Budget Speech for the year 2019-20 made on 8th February 2019 had announced that a Comprehensive Karasamadhana Scheme will be introduced with a view to reduce the arrears arising out of the enactments administered by the Commercial Taxes Department which existed before the introduction of Goods and Services Tax (GST) Act. Accordingly, a Scheme for waiver of penalty and interest was formulated and issued vide orders read above.

Trade and Industries have represented to the Government for extension of time upto 31st July 2019 for completion of assessment / re-assessment / rectification and withdrawal of appeal and other proceedings to avail the benefits under Comprehensive Karasamadhana Scheme, 2019 vide orders read above.
