 - The successful bidder shall, in addition to the bid amount, be liable to pay KGST & CGST @ 2.5% each, calculated on the bid-amount in the event of the dismissal of Writ Petition No.16743/2021[T-RES]
 - 6. The invitation of bids for the sale-by-auction of the goods in its current condition, whatever this condition happens to be, which is also known as the "as is where is" clause.

- 7. Those interested in participating in the sale-by-auction may check the goods for quality and quantity at their cost on 08-11-2021 and 09-11-2021 from 11.00am to 5.30pm.
- 8. The minimum amount of bid shall be Rs.1,21,62,150.00(Rupees one crore twenty one lakks sixty two thousand one hundred and fifty only). The pre-bid security deposit of Rs.12,16,215.00(Rupees twelve lakks sixteen thousand two hundred and fifteenonly), in the form of a banker's cheque or a demand draft payable at Mangalore infavor of "Assistant Commissioner of Commercial Taxes (Enforcement)-1, West Zone, Mangalore" along with the bid in a sealed envelope (the banker's cheque or the demand draft should not be included in the sealed envelope), shall be submitted on or before 12-11-2021 during office hours at the office of Joint Commissioner of Commercial Taxes (Enforcement), West Zone, Mangalore.
- 9. Thebankerscheques or the demand draft submitted by those who fail in the auction will be returned on the day of the auction.
- 10. The sealed envelope submitted by the bidders will be opened intheir presence at 11.00 am on 15-11-2021.
- 11. The successful bidder shall pay the bid-amount within 20-11-2021 failing which he/she/it will forfeit the pre-bid security deposit submitted by him /her/it and the next highest bidder will be deemed as the successful bidder provided that the sum of the pre-bid security forfeited from the successful bidder and the bid of the next highest bidder is a minimum of Rs.1,21,62,150.00/-. The Demand Draft in this regard has to be issued favouring "Assistant Commissioner of Commercial Taxes (Enforcement)-1, West Zone, Mangalore payable at Mangalore and the amount realized will be deposited in an interest bearing fixed deposit as per the directions of the Hon'ble High Court of Karnataka in its order dated:29-09-2021.
- 12. The process of auction will be cancelled where no bid is received, or the auction is non-competitive due to lack of adequate participation or due to low bids. However, if there is at least one bid for the minimum amount mentioned above, then the person who bid shall be declared as the successful bidder even when he is the sole bidder.
