6. The undersigned reserves the right to accept or reject or Postpone any bid or call off the Auction Sale before the proceedings are completed, for certain reasons.
7. The Bid amount quoted by the bidders will be displayed on the Notice Board. If the quoted prices are reasonable, the Bidder with highest quoted price will be intimated through e mail



- only to take the possession of the goods, Therefore bidders are here by advised to check their e mail. The successful Bidder shall make the Full payment of bid amount.
8. The successful bidder, if registered under the GST Act has to pay the applicable CGST, SGST, IGST under RCM before taking delivery of the goods.
  9. The successful bidder, if not registered under the GST Act has to pay the applicable CGST, SGST, IGST after obtaining temporary registration under GST Act-2017 from the undersigned and submit the payment challan before taking delivery of the goods.
  10. The successful bidder shall deposit the bid amount through online within three days of intimation from the undersigned and shall remove material within two days after making full payment of bid amount. In case the successful bidder fails to deposit the bid amount within the stipulated time, the EMD is forfeited and the bid will be awarded to next highest bidder or fresh Auction Proceedings will be initiated if the quoted prices are not reasonable.
  11. The EMD of the unsuccessful bidders will be refunded after completion of the Auction proceedings.
