Conditions:

- 1) The goods will be auctioned in “As is where is” basis and in a single lot.
- 2) As there is a complete restriction on public transport up to 24.05.2021 due to lockdown (Covid-19) in Ballari district, persons who are interested in bid and willing to verify the groundnut seeds shall furnish Adhar Card along with their photographs to this office e-mail before 5.00 PM of 22.05.2021. Sample photo of the groundnut seeds will be sent to their respective e-mail.
- 3) The persons who are interested to verify the Groundnut seeds in person and participate in auction on 26.05.2021 shall furnish the Adhar card, PAN card, postal address, e-mail address, mobile number and information from which place do they come for participation of bid along with their photographs to this office e-mail before 5.00 PM of 24.05.2021. The arrangement of e-pass from the Deputy Commissioner of Ballari will be provided to those who participate in the bid from their respective places.
- 4) The Bidder shall quote the bid amount in Rupees per Kg basis.
- 5) The persons who are interested to participate in auction should deposit EMD of Rs.35000-00 (Thirty five thousand rupees only) for ground nut seeds Goods with the undersigned by way of D.D/Pay order drawn in favor of Commercial Tax Officer(Enforcement)-10, Ballari on or before 11.30AM of 26-05-2021.
- 6) The right to accept or reject or postponement of the auction sale lies with the undersigned.
- 7) The Bid amount quoted by the bidders will be displayed in the notice board and the bidder who has quoted highest price will be intimated to lift the goods which are intended to the auctioned on payment of bid amount.
The Successful bidder, if registered under the GST ACT-2017 has to pay the applicable CGST&SGST before taking the delivery of Goods.
- 8) The successful bidder, if not registered under the GST Act-2017 has to pay the applicable CGST,SGST after obtaining temporary registration under GST Act-2017 from the undersigned and submit the payment challan before taking delivery of the goods.
- 9) The undersigned after getting the approval from the higher authority regarding highest bid quoted by the successful bidder and then afterwards the successful bidder shall deposit the bid amount within **SEVEN DAYS** through online/e-payment by taking temporary registration and said purchase will be treated as URD purchases. If bidder fails to deposit the full bid amount within **SEVEN DAYS**, the EMD of Rs.35000-00 (Thirty five thousand) for Groundnut Goods will be not be refunded back.
- 10) In case successful bidder fails to deposit the bid amount within **SEVEN DAYS**, the bid will be awarded to next highest bidder and after getting the approval from the higher authority or fresh auction proceedings will be initiated if the quoted prices are not reasonable.
- 11) The successful bidder should lift the goods within **SEVEN DAYS** from the date of communication on payment of bid amount through online.

- 12) The EMD of the Unsuccessful bidder shall get back the EMD after completion of the Auction proceedings.
