- 4. The Bidders may bid for both COOL LIP FILTER TOBACCO, Bidder shall deposit Earnest Money Deposit of Rs.3,25,0000/- by way of D.D. drawn in favor of Commercial Tax Officer (ENF)-09,Bengaluru. The Bids which is not accompanied by DD for the EMD will not be considered for Auction.
- 5. The bidders are required to quote their bid in sealed cover by specifying the Rate in Rupees /pouch of 8 gm for Cool Lip Filter Tobacco(excluding GST at 28% and Cess at 160 %) and Rate in Rupees/ pouch of 6.8 gm for Cool Lip Filter Tobacco (excluding GST at 28% and Cess at 160 %).
- 6. - 7. The undersigned reserves the right to accept or reject any bid or call off or postpone the Auction Sale before the Proceedings are completed, without adducing any reasons.
- 8. The bids in Sealed covers will be opened on 24 -02-2021 @ 11.30am at the office in presence of attending bidders and successful bidder will be announced.
- 9. In case where, more than one bidder quotes highest bid with same value, then all such bidders shall have to submit bids once again in sealed covers within one hour on the same day and bid amount is not lesser than initial bid.
- 10. The successful bidder, if registered under the GST Act has to pay the applicable CGST, SGST, IGST and Cess under RCM before taking delivery of the goods.
- 11. The successful bidder, if not registered under the GST Act has to pay the applicable CGST, SGST, IGST and Cess after obtaining Temporary registration under GST Act-2017 from the undersigned and submit the Payment Challan before taking delivery of the goods.
- 12. The successful bidder shall deposit the bid amount through Online within a days of intimation from the undersigned and shall remove material within two days after making full payment of bid amount. In case the successful bidder fails to deposit the bid amount within the stipulated time, the EMD is forfeited and the bid will be awarded to next highest bidder or fresh Auction Proceedings will be initiated if the quoted prices are not reasonable.
