

GENERAL INFORMATION

1. The bidder should be a registered tax payer under the provisions of the Karnataka Goods and Services Act, 2017 and should furnish satisfactory evidences for having registered under the provisions of the said Act. He should be an up-to date filer of the returns under the said Act.
2. The price of the products to be quoted should include all taxes and statutory levies. No extra amount of tax or statutory levies will be paid in the event of upward revision of the rate of taxes. On the other hand, if there is down ward revision of the tax rate during the intervening period, the tax amount will be restricted to the extent of revised rate.
3. The bidder should also be registered under any other statutes required of him.
4. The successful bidder should provide after sales service for at least one year.
5. The warranty/ Guarantee for the product supplied shall be as specified by the original equipment manufacturer and in the event of any defects in functioning of the products supplied, the successful bidder should ensure repair or replacement of the product during warranty period.
6. The products should be brand new and strictly conform to the technical specifications set out in this document.
7. Alternative tender will not be considered.
8. Tender awarded is non-transferable. The successful bidder should not sub-contract the supply. In such as case the bidder is deemed to be disqualified from the anterior date.
9. Conditional tenders are liable for rejection.
10. Tenders without or insufficient amount of EMD will be rejected outright.
11. Intending tenderers can have detailed information from the office during office hours. The Additional Commissioner of Commercial Taxes (Enforcement), South Zone, Bengaluru reserves the right to reject any or all tenders without assigning any reason.
12. Security deposit as prescribed in the contract document would be returned to the unsuccessful bidder after finalization of the tender process within three months.
13. The bidder/agency shall submit their quotations in the format given in Part-1 of the tender document.
14. In case more than one agency stands L1, firstly, agency which is registered under the provisions of Indian Companies Act will get preference. The Limited Liability Partnership concern, the Private Limited Company, the Partnership Concern and the Proprietary concern will be next in order of preference. Secondly, the agencies having higher turnover will get preference over others.
15. For all the disputes arising out of the agreement the jurisdiction of the court shall be at Bangalore for both the parties.
16. The successful bidder will be fully and solely responsible for any violations under the relevant statutes and any such violation will be a breach of contract and the Department at its discretion, may cancel the contract. The successful bidder shall also be liable for any pecuniary liability arising on account of any violation of any of the provisions of the relevant laws.
17. In case of any ambiguity or doubts with regard to the terms, clauses used in the tender documents, clarifications should be sought in writing before submitting the tenders, failing which, the decision of the Department in all such matters shall be final and binding on the service provider.

18. The scope of service is liable for alteration by way of deletions or additions at the discretion of the Department.
19. In case any dispute or difference arises between the Department or its representative and the successful bidder on any matter within the scope of this contract, then either party shall forthwith give written notice of such dispute or difference to the other party and such dispute or difference shall be referred to the Commissioner of Commercial Taxes (Karnataka), whose decision will be final
20. If any loss or damage is caused to the Department by non-compliance of the obligations under this agreement by the successful bidder, he is liable to make good such losses and the Department shall be entitled to recover the same from the bidder.
21. Tender documents shall be submitted manually in sealed cover to the office of the Additional Commissioner of Commercial Taxes (Enforcement), South Zone, VTK-2, Koramangala, Bengaluru-47 during office hours.
22. Final acceptance of the tender rests with the Additional Commissioner of Commercial Taxes (Enforcement), S.Z, Bengaluru who reserves the right to accept or reject any or all tenders without assigning any reason therefor.
23. Submission of the tender by the bidder implies that the conditions of contract have been read and is aware of the scope of the supply.
24. Tenders will be opened in the presence of bidder or their authorized representatives on the date and time specified here in.
25. Tenders not submitted in the prescribed form will be rejected. Tenders which propose any alterations in the supply specified or containing other conditions of any sort will be rejected.
26. Unsuccessful/rejected Bidder's EMD shall be refunded within three months.
27. The successful bidder shall attend the office on a date to be fixed and intimated to him for executing agreement etc. failure on the part of the successful bidder to execute the contract agreement within 1 week from the receipt of written communication of letter of acceptance to this effect, would entail rejection of the bid and forfeiture of EMD


