



1. Conditions:

1. Bidders / service providers shall not be under declaration of ineligibility for corrupt and fraudulent practices issued by Government of Karnataka.
2. Bidders / services providers should attach all the scanned copies of PAN number, service tax registration and professional tax registration certificates. Failing which the bid will not be considered.
3. EMD payment is through D.D. and in favour of Joint Commr. Of Comml. Taxes (Admn), DVO-3, Bengaluru, shall be made as one single transaction and payments made in part are liable for rejection.
4. EMD amount of unsuccessful service provider will be refunded after tender process is completed.
5. The tender inviting authority reserves the right to accept or reject the tender without assigning any reason. Approved service provider shall execute services as per the directions of the Joint Commr. Of Comml. Taxes (Admn), DVO-3, Bengaluru. The service provider will effect the services under the supervision of the officer and the staff nominated by the tender inviting authority.
6. The servicing of 10 AC units includes services of indoor units, outdoor units and checking of Gas Leakage/ Gas Top-up and any other service required for AC units. Servicing of AHUs includes servicing of Fresh Air Fan 25000 CFM-2 NOs., servicing of Fresh Air Fan 30000 CFM-1 No. servicing of Fresh Air Dampener/Duct opening-3 Nos. servicing of Collar Damper/Rectangular Grills-Approx. 170 No.(680 RFT) and cleaning of Air filters through chemical and water processes and any other service required.
7. The service provider will effect servicing during the Government Holidays without damaging the properties in the premises. Any damages to the properties in the premises will be borne by the service provider.
8. Corrigendum/modification/corrections, if any will be published in the website.
9. The rate quoted in the tender should be clearly mentioned both in figures and in words. If any discrepancy is found in figures and words, the bid will be disqualified.
10. The service provider should employ skilled personnel towards servicing work.



11. The service provider shall provide the services to the satisfaction of the tender inviting authority without any complaints whatsoever. The office and the staff nominated will evaluate quality of service provided and only after completed evaluation of the services, the payments will be released.
12. The successful tenderer will be awarded the work by the Joint Commr. of Comml. Taxes (Admn), DVO-3, Bengaluru and shall complete the work within 30 days of receipt of the work order.
13. The Service provider shall ensure providing of services once again within three months if the discrepancies are found in the services rendered and shall immediately attend to the short fall in the services noticed.
