General Conditions for Eligible Tenderers

1. Tenderers should not be associated or have been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by the purchaser to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of the goods to be purchased under this.
2. Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Karnataka.
3. The bidder shall ensure credit of tender processing fee and EMD into the respective receiving bank accounts of e-procurement on or before the last date of bid submission.
4. The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for tenders. The department shall not be responsible for non accessibility of e-procurement portal due to internet connectivity issues and technical glitches.
5. EMD payments through e-payment mode, shall be made as one single transaction and payments made in part are liable for rejection.
6. The Additional Commissioner of Commercial Taxes(Enforcement)-South Zone, Bangalore has right to accept or reject or postpone any or all of the tenders without assigning any reasons.
7. All other terms and conditions as per the tender document.
8. The quantity of the furniture shown in tender document is approximate and this quantity may increase as per the requirements without any change in unit price or other terms and conditions.
9. In case of any dispute, the decision of the Additional Commissioner of Commercial Taxes(Enforcement)-South Zone, Bangalore is final and binding.
10. The net rate quoted per item/unit of goods shall be for FOR, destination, which should include all taxes, insurance, freight charges, etc. while quoting rate, this point should be kept in mind.
11. Materials to be supplied should be of good quality

12. The bidder shall carefully study and understand all the bid specifications, commercial, technical and general conditions.
13. Incomplete tenders/tenders without specified EMD are liable to be rejected. The EMD of the unsuccessful tenderers shall be returned within a reasonable time, after conclusion of agreement with the successful tenderer's. Earnest Money Deposits shall not bear any interest on it and the EMD shall be returned to the successful tenderer only after execution of agreement and furnishing security deposit of the total value of the purchase order.
14. The materials supplied shall be guaranteed for satisfactory performance for a period of 12 months from the date of delivery. In case the materials are found defective during the above guarantee period, the supplier shall replace the materials free of cost to the purchaser at site otherwise security deposit will be forfeited.
15. Security deposit will be forfeited, if the tenderer fails to supply the materials within the stipulated time.
16. The successful bidder shall furnish performance security deposit @ 5% on the contract value in the form of bank guarantee having 12 months validity and it does not carry any interest.
17. The bidder should not have been black listed by any Government or non Government institutions or Government Department undertaking/public enterprises.
18. The bidder shall quote in two part system, one for technical bid and other for price bid. Price bid will be opened after satisfaction of technical bid.


