- 2) The bidder should be registered under the Service Tax Act.
- 3) The bidder should be registered under Provident Fund Act.
- 4) The bidder should be registered under ESI Act.
- 5) The bidder should have an office in Bangalore.
- 6) The bidder should have a minimum of 20 clients on his rolls with a minimum of 5 guards per client; list of clients on rolls of the bidder should be indicated in the prequalification bid;
- 7) The bidder should have a minimum of 100 security guards on his rolls;
- 8) The bidder should submit proof of Permanent Account Number (PAN) assigned by the Income Tax Department
- 9) The bidders should be registered under Karnataka Tax on Profession Trade, Callings and Employment Act-1976 and supported by the copy of certificate.
- 10) The annual earnings of the bidder for the past 3 years and proof of the same (such as income tax returns or balance sheet) should be submitted along with the tender document;
