Tenders are invited under two covers system, from authorized dealers/ service providers in pest-control solutions for eradication of insects/rodents in Vanijya Terige Karyalaya-I, Gandhinagar, Bangalore-560 009.

The above services are for a period of One Year commencing from the date of award of the Tender. The prescribed tender form and the document showing 'terms and conditions' of this tender can be obtained from the Assistant Commissioner of Commercial Taxes (General)(Tel.No. 22205239) in the above given address during office hours on all working days or downloaded from the website: http://ctax.kar.nic.in.

The first sealed cover should contain (i) particulars of VAT registration, (ii)VAT clearance certificate, (iii) PAN details of Indian Income Tax Act, 1961, (iv) letter or certificate for having been appointed as authorized service provider in pest-control mechanisms, and, (v)demand draft for Rs.10,000/- towards EMD. This cover should be superscribed with the words "Pre qualification bid for Pest Control." The second sealed cover should contain the financial bid in the prescribed form and should be super scribed with the words "Financial bid for Pest Control." The sealed covers containing the 'Pre qualification bid' and the 'financial bid' should be enclosed in another sealed cover superscribed with the words "Tender for Pest Control solution in Vanijya Terige Karyalaya-1, CTD." and should be addressed to the Commissioner of Commercial Taxes (Karnataka). The bids should be unconditional. Conditional bids will be summarily rejected. The financial bid covers of only those bidders who satisfy the prequalification requirements after evaluation of the prequalification bid will be opened.

The bidder should satisfy all the terms and conditions laid down in this behalf.

The last date for submission of tender is 22-09-2009. The sealed cover containing the 'pre qualification bid' and the 'financial bid' should be delivered to the Additional Commissioner of Commercial Taxes (Head Quarters)-II on the 3rd floor, Vanijya Terige Karyalaya-I, Gandhinagar, Bangalore. Tenders received after 4.00 PM on 22-09-2009 will be rejected.

The pre-qualification bids will be opened on 24-09-2009 at 5.00 PM in the presence of available bidders (written intimation to this effect will not be given to individual bidders) and the financial bids of those who qualify in the pre qualification bid will be opened on 25-09-2009 at 4.00 pm in the office of Commissioner of Commercial Taxes (Karnataka) , I floor, VTK, Gandhinagar, Bangalore.

Terms and conditions prescribed in relation to tender notification No. VTK/CR-88/08.09 dated: 14-08-2009 for providing services for pest control in Vanijya Terige Karyalaya-I, Gandhinagar, Bangalore:

- 1. The bidder should be an authorized service provider in pest-control solutions. Proof of the same should be submitted along with the tender document.
- 2. The bidder should be a registered dealer under the KVAT Act, 2003 or under the General Sales Tax Act of any State and proof of the same should be submitted along with the tender document.
- 3. The bidder should submit a 'Tax clearance certificate' issued by the Sales Tax / Value Added Tax authority concerned covering the period up to the date of publication of the tender.
- 4. The bidder should submit proof of Permanent Account Number (PAN) assigned by the Income Tax Department.
- 5. The bidder should enclose in the sealed cover containing the pre-qualification bid a demand draft for Rs.10,000/- (Rupees Ten Thousand only) as earnest money deposit (EMD), drawn on any scheduled bank favoring "Commissioner of Commercial Taxes (Karnataka), Bangalore" payable at Bangalore.
- 6. The EMD of the unsuccessful bidder will be returned only after finalization of the tender process.
- 7. The EMD of the successful bidder will be returned only after successful completion of delivery of goods covered in this tender.
- 8. The service provider should:
 - i) eradicate cockroaches, flies, silverfish, bugs, red, black and white ants, ticks etc., in the entire building including its cellar, garage, ground floor and 1st to 8th floors (including roof).

- ii) carry out eradication work at least once every month with not less than 12 services in a year.
- iii) eradicate house mice, roof rats, drain / water pipe rats, bandicoots etc in the entire building including its cellar, garage, ground floor and 1st to 8th floors (including roof).
- iv) carry out eradication work at least once every 15 days with not less than 24 services in a year.
- The bidder should mention net value of the services to be provided and tax element thereon (Sales Tax or VAT) separately and also enter the total value in the financial bid document.
- 10. If it is detected by CTD that the successful tenderer is not carrying out the pestcontrol measures effectively, then CTD will cancel the award of the tender forthwith, by forfeiting the EMD and such tenderer will be black listed.
- 11. CTD reserves the right to reject all or any of the tenders.
- 12. Conditional tenders will be rejected.
